EYI SETTLEMENT K'E EDTLAGHONEH GHA GHENI?

K'odhedi nethe Canada adi ghu gheh dta dene Class Members k'esjh ghultai tzamba bedtzen ghedughudi dta daiah nisi ghelnadtzeghedtihn nisi dta benih dta tai yadtih dta tai bedtzen nadztzilh dta tai beghahn k'e nadztzedhed nighlei ghidta tai "Federal Indian Hospital" naidheh nisi ekughu ghonah. Tzamba dta dene dtzen naghani gha si \$10,000 ghotzjh \$200,000

ghodtzen neldtei Canada ghodtzh tzamba dta ghundtlethe ghonehe ghunidhen de eyi ghadeh ghuahneldeh ghaldhen ghiidta.

- belede tthi \$150,000,000 nindtai gha Indigenous Services Canada yedta segholeh gha eyi dta Class Members kesj daghulta ghedja desi ghenakanelni senindeh gha dtau beghalada lesi ekughu nedidi Settlement Agreement ghotle desi ekughu ghoyagha.

EDLAGHI BEHL AH EYI PROPOSED SETTLEMENT GHOLJH SI?

Eyi classes gholjh dtqndtu beghaqn yadtih nindtahn sj:

- 1) **Primary Class Members:** eyi detthiyeh dta neidi ghanai kuwe "Federal Indian Hospital" naghindeh nisi dtau Federal Government bedaghade dtau nedidi Class Period sni ghulyai ekughu (January 1, 1936 ghodtzhn December 31, 1981) ghodtzhn.
